Release, waive, discharge and covenant not to sue Sunkist Kids Wrestling Club, Arizona State University, it's affiliated clubs, their respective administrators, directors, agents, coaches and other employees of the organization, other participants, sponsoring agencies, sponsors, advertisers, and, if applicable, owners and leasers of the premises used to conduct this event, all of which are hereinafter released from any and all liability to the undersigned, his or her next of kin, for any and all claims, demands, losses or damages on account of injury, including death or damage to property, caused or alleged to be caused in whole or part by the negligence of the releasee or otherwise.
